Accounts are invoiced according to your request at the time of registration and you are responsible for all fees whether your child attends or does not attend. **Payments are the sole source of funding for the program and the staffing of the program.** If you have a requested change in enrollment mid-month, the billing will be updated the following month billing cycle and will not be pro-rate for a credit.

Payments are due on the 15th of every month. If the 15th falls on a weekend or holiday, payment must be received on the business day before the 15th. A \$30 late fee will be applied on the 16th of the month. Payments not received by next billing cycle will result in the removal of the program.

Our preferred method of payment is online SchoolPay. Visit R. B. Hunt's website for SchoolPay link to set up an online payment account. Cash payment can be made directly in the front office. We cannot be responsible for cash sent to school in your child's folder. All checks returned unpaid by your bank will be turned over to collections. Two returned checks on any one account will result in mandatory cash or money order payments for all subsequent fees due.

# EXTENDED DAY PAYMENT INFORMATION

The school calendar year consists of 180 days that the children are in attendance. Each month varies from another in the amount of days attended. Each installment covers 18 days of child care and divided into 10 monthly payments. Florida state law Article VII, Section 10; requires that all services must be paid in full prior to services being rendered. Due to state law and regulation, payments are due on the 15th of the month. If balance is unpaid by the date in the "Covers Your Childs Care Through" box below, your child will be unable to attend Extended Day until balance is paid in full.
